**Primary Election: March 19 2024**  
**General Election: November 5, 2024**

### You are eligible to vote:

- if you are a citizen of the United States and a resident of Ohio at least 30 days before the election;
- in a primary and general election if you are 18 years of age by the day of the general election;
- if you registered to vote at least 30 days before the election.

### Also

- If you moved or changed your name and did not update your voter registration, you can still vote a provisional ballot in the precinct where you now live. When your registration is verified, your vote will be counted.
- All voters must bring acceptable photo identification to the polls such as an unexpired Ohio driver's license or state identification card with present or former address, so long as the voter's present residential address is printed in the official list of registered voters of that precinct. Other acceptable photo identification includes military identification or an unexpired photo identification issued by the US government or the state of Ohio that contains the voter's name and current address.


Please note that identification requirements have changed effective 2023.
